RELEASE NOTES ALPO VERSION 1.33 -RELEASE CHANGE ON 21.03.2017

Dear Sir or Madam,

the German Customs Administration has implemented the ATL@S version 8.7 in October 2016. The soft migration ends on 26 March 2017. After this date, the ATLAS 8.7 release label is compulsory in the EAS procedural area.

The ASumA is a security-related customs declaration and is to be classified in the context of the ICS / ECS (Import / Export Control System). An ASUMA is to be issued in principle, if goods are being brought into the customs territory (even temporarily) of the Union and there is no customs declaration or re-export declaration with the relevant security data issued. Another use case is transshipments when goods are stored in the port for more than 14 days or if the receiver of the goods has changed during storage.

Under the new ATL@S version within the export-process, for the current procedure of the exit summary declaration (AsumA) an expansion in this process sector will be installed. In addition to the MRN (Movement Reference Number) of the AsumA also releases, prohibitions or control arrangements are received via status interface by the parties in the future. The MRN must be released by the customs authorities, so the goods may be exported.

The dbh products have taken up the new requirements and integrated them into the processes. We distinguish between two modes:

- **Customer variant:**
In the customer variant, you can enter the MRN number assigned by ATL@S with its respective process status ("accepted", "control arrangement", "prohibition" and "release").
- **BHT / WHT variant:**
In this variant, you transfer the relevant ASumA registration data together with the export declarations to dbh and, both - the creation of the ASumA and the
