Release Notes ALPO Version 1.40 -Release at 04.06.2019

Dear Sirs and Madames.

the German customs administration has put the ATL @ S-Version 8.9 / AES-Release 2.4.3 into real operation on 22.09.2018.

The soft migration ends on 14.07.2019. After this date, the release indicator ATL @ S 8.9 is mandatory in the procedure area EAS (ATLAS EAS = General Inbound / Outbound summary declaration).

The ASumA is a safety-related customs declaration and must be classified in the environment of the ICS / ECS (Import / Export Control System). In principle, an ASumA is to be surrendered if goods are (even temporarily) removed from the customs territory of the union and no customs declaration or re-export notification with the security-relevant data is available. Another application is in transshipment, when goods are stored for more than 14 days or during storage a change of recipient has taken place.

As part of the new ATL @ S version 8.9, an extension will be introduced in the area of export for the previous procedure of the summary exit declaration (ASumA).

The major changes in ASumA from ATL @ S Version 8.9 are the following:

- When submitting an ASumA, it needs to be indicated whether the ASumA is submitted before or after the presentation.
- In the case of a "premature ASumA" (submission before presentation), the confirmation of the presentation by the ASumA responsible party is mandatory.
 For this there is a new message "E_EXS_CON" in the ASumA process
- cession and prohibition will still be communicated with the message "E_EXS_STA", but this can now also be done on position levels.
- It is necessary to inform the customs about the exit of the goods via "E_EXS_NOT" (exit confirmation).
- After confirmation of exit, each ASumA MRN will be closed by the Customs.

- Modification of an ASumA MRN is still not possible. If, nevertheless, a change of the ASumA-MRN is necessary, the ASumA responsible person must cancel the existing ASumA-MRN. For this there is the new message E_EXS_CAN.
- From version ATL @ S 8.9 it is possible to refer to a storage stock (SumA) in an ASumA application and to specify a termination share.

The new requirements have been designed and implemented by dbh in the BHT and are therefore also of importance to ALPO customers who use the ALPO BHT module. At the moment no changes in the BHT interfaces are necessary as the logic of the new ATL @ S messages can be handled with the BHT processes. However, in the coming weeks we will have to revise the concept of "client mode" for reasons of the new presentation and closing processes in the ASumA. The background is that within the BHT in the "client mode" no presentation and final message to ATL @ S are triggered. The changes concerning ASumA in ALPO are not visible for the ALPO customers in the 1. step to take place, but have to be regarded as preparation for possible future ASumA innovations.
